FEE POLICY

The school fee is applicable for the academic year April 2023 to March 2024.

Application form fee is to be paid online. This amount is non-refundable and does not guarantee admission.

At the time of admission, the parent is required to pay the following:

- Admission Fee: Non-refundable
- April 2023 to March 2024 Fee: Refundable if student is changing the school before start of academic year.

The same has to be paid before the due date. If the same is not paid within the stipulated time, the admission will be deemed cancelled and the next eligible student will be offered the admission.

In case of mid-term withdrawal of a student, fees will be charged till the month of withdrawal. Pupils joining the school mid-term should pay the fees as per the admission procedure. This also includes the Admission fee.

In case of refund; it will be processed through cheque payment from the school.

* The School Leaving Certificate will be issued only after the clearance of all dues and on return of Library books. The School Leaving Certificate will not be issued during vacations.

To postpone payment of fees in emergency situations, prior permission must be secured from the School Management in writing.

MODE OF PAYMENT:

- Fees are to be paid online through any Bank Credit Card, Debit Card, Internet Banking, UPI or Demand Draft as per the due date. Online payment will be accepted through HDFC Bank (<https://paydirect.eduqfix.com/app>)

- Demand Draft drawn in favour of "DOMINIC SAVIO KINDERGARTEN". The Pupil's Name, Class, Section, Student ID, HDFC Bank Account number and Mobile number are to be entered on the reverse side of the Demand Draft. Fee challan has to be collected from Accounts office in School and it has to be submitted along with Demand Draft in HDFC Bank, Seawoods Branch. **Kindly note Demand Drafts will not be collected after the due date for fee payment.**
